

The Coupon Follow Scholarship Program Official Terms & Conditions

NO PURCHASE NECESSARY. VOID WHERE PROHIBITED BY LAW.

1. **ELIGIBILITY.** The Coupon Follow Scholarship for Financial Awareness is sponsored by **NextGen Shopping LLC / CouponFollow.com (the "Sponsor")**. To enter, applicant must be:
 - a) eighteen (18) years of age or older,
 - b) legal resident of the fifty (50) United States and the District of Columbia, and
 - c) accepted or currently enrolled in an accredited college or university.

Current employees, officers, affiliates, partners and agents of Sponsor and their immediate family members (spouse, parents, siblings and children) and persons residing at the same address are not eligible to win. Void where prohibited.

2. **HOW TO ENTER.**

Submit Application via <http://couponfollow.com/scholarship> (the "Site") no later than June 30, 2016 at 11:59 pm Eastern Time. Sponsor may decide to extend the deadline for submissions if it deems, in its sole discretion, the number of applicants too low, or to shorten the deadline if the number of applicants is too high. Application must contain:

- a) name,
- b) answers to all required essay questions,
- c) contact information.

Multiple or duplicate entries from the same individual will be disqualified. All submissions are final and no corrections or substitutions will be allowed. Sponsor shall not be liable for unintelligible, late or lost Application. By submitting an Application, you fully accept and agree to these Official Terms and the decisions of the Sponsor, which are final and binding. You acknowledge that the Sponsor and its related companies may also call and/or send you information it thinks may be of interest to you.

3. **JUDGING CRITERIA: Sponsors panel will judge Applications based on the following criteria:**
 - a) answer quality (25%),
 - b) creativity (25%),
 - c) originality (25%),
 - d) grammar (25%).

During July 2016, Sponsor's panel of judges will select one (1) winner and notify him or her by e-mail. Sponsor shall not be liable if any winner notification is lost or not received for any reason.

4. **PRIZE.** Scholarship Prize shall be a check in the amount of five thousand dollars (\$5,000.00) made payable to the accredited post-secondary institution of higher education attended by the winner who must submit proof of enrollment within seven (7) business days of notification of winning the scholarship. 10. **TERMINATION.** In the event Sponsor is prevented from continuing with the Scholarship Program by any event beyond its reasonable control, then Sponsor shall have the right in its sole discretion to modify, suspend, or terminate the Scholarship Program.
11. **MISCELLANEOUS.** Any legal matter that may arise out of or be related to The Coupon Follow Scholarship for Financial Awareness shall be governed by the laws of New Jersey. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the application process or the operation of the Scholarship Program or the Site, to be acting in violation of these Official Terms, to be submitting responses dishonestly or inaccurately, or to be acting in an unsportsmanlike or disruptive manner. In the event of a dispute as to the identity of any applicant, the authorized account holder of the email address

used to enter will be deemed to be the applicant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. If an Application is confirmed by Sponsor to have been erroneously deleted, lost or destroyed, the applicant's sole remedy shall be another Application, if time permits. Sponsor's failure to enforce any term of these Official Terms shall not constitute a waiver of that or of any other provision.
